- 4. Council Action Items & Updates
 - a. Queer Youth Center & Lead for Minnesota Robert Harris, a representative from Lead for Minnesota, joined us to discuss the possibility of St. John's committing to be a host site for a fellow.
 - b. ECB Updates
 - ECB is exploring closed captioning options. ECB recommends that we move ahead with the closed captioning options. ECB feels that church members should not be charged for closed captioning services for events (weddings, etc.). ECB would like to discuss the sound panels in more depth.

- 5. Consent Agenda Items
 - a. Kristy Harms made the motion to approve St. John's committing to \$5,000 per year for the next two years, in committing to be a host for Kieran with Lead for America. For the first year, \$600 would come out of the Foundation's Youth and Children's Funds, and \$4,400 balance coming from Grace Overflowing Benevolence Fund. The

second year, the funds would come from a combination of Foundation funds and money raised by the Youth board. Rob Nutt seconded the motion. The motion carried unanimously.

- Mark Gleason made an amendment to the motion that St. John's support would be contingent upon the program continuing in Northfield. Rod Christensen seconded the amendment. The motion carried unanimously.
- b. Mark Gleason made the motion to approve the FAQs regarding St. John's providing streaming services for non-service events (weddings, funerals, etc.). Paul Beck seconded the motion. The motion carried unanimously.
- c. Suzanne Pfau made the motion to ask the congregation to wear masks at least through June. Gene Bakko seconded the motion.
- d. Jane Rizzo made the motion to approve the minutes and financial report from April's council meeting. Merilyn Calcutt seconded the motion. The motion carried unanimously.
