Adult Ministry and Education

Adult Education & Ministry Board St. John's Lutheran Church 9 May 2017

Summer Suppers

Our first Summer Supper event has been scheduled for June 21st; an article in the Voice has announced this this past month, and noted that another event will be planned for later in the summer, likely on August 16th. Jen Welbaum will be tabling for this event tomorrow night (5/10) at Wednesday Night Meal; Alyssa will drop by to introduce herself and visit about upcoming details (will ask about any poster needs—and ask Jon R to handle if needed, advertising ideas, note that a member of our board will sit and table on Sundays, etc.)

Upcoming Tabling for this event:

- Genevieve Q can table on May 21st (NHS Senior recognition Sunday)

Alyssa will check to see if a notice is going in the Sunday bulletins – will probably just shorten the Voice announcement, edit as needed and confirm that we have the details correct. Will also request that a pastor make an actual announcement during the service to call attention to the sign-ups.

Quarberg Event

The event that our board sponsored for the youth fundraiser will take place on June 25th (2:00p-4:00p) at the Quarberg home, 1604 Cannon Valley Drive in Northfield. Genevieve & Sandra discussed some details while awaiting the arrival of the rest of the board tonight, and it was decided that together they would obtain the refreshments needed for the event, and provide for roughly fifty people, just in case. We can show up and help where needed, or just come and enjoy the show.

Fall Service Day

Board members present are not sure why it's important to do this, or why our board should be involved...this type of event does not appear to clearly fall into either education or ministry categories, as they define them, so is perhaps not under our purvey. When we find out about a pressing need in the community, then we can respond, but we're not sure it's our place to go seeking out little things to minister for the sake of ministering.

Alternative idea: Go out and visit different churches, different things in the community. Different from traveling service opportunities, where learning/experiences are going on.

Forums

We had a lengthy discussion about various aspects of the Forum. Board members present feel that this is the most important thing that this board does. The current proposal from Pr. Davis for an annually-appointed committee of five people seems to make sense; a likely improvement over the larger

committee that was previously working through this. It's thought that one person from this board should be on the committee (and chair from our group), and at least one of the pastors should be in attendance as well. Jon Reid suggests Eric Lund as a good member for this committee; a great asset for this sort of thing. It's agreed that we should get representation from across age groups for a committee of this sort. We could also experiment with Forums in that if Pastors want to emphasize something or invite certain speakers, the schedule would allow for that, but then let the Board pick that up and run with it with small groups subsequently (ex: following Alan Storey event, would have had small group events on related topics); we could connect some Forums to later/ongoing events (Pub Theology, afternoon studies, etc.). Board interested in choosing or helping to choose these committee members.

Socializing with coffee is often more appealing to many congregation members; what if we don't have Forum every Sunday, or had some small group activities offered occasionally? Schedule in the openings, and then see if there are openings remaining in which to try some more experimental.

It is noted that there was a large attendance for the St. Olaf Gospel Choir this past Sunday's Forum, so we know that music is a big draw.

In Sanctuary, Forums have to be rushed out because the space will be used for next service; what if we had some Forums in the library space? If we had more mobile seating in that room that could be moved around, it might lend itself more to that sort of thing.

If we wanted to give more opportunity for input, perhaps an announcement could be made at the service that could mention that if anyone is interested in certain topics being presented, they could submit ideas.

Closing Question

Genevieve invited us to consider and ask others the following question in the coming weeks: What would people like our church to do for them in their faith? To strengthen their faith, etc.?

Benevolence and Social Concerns

Notes from Benevolence and Social Concerns Board, May 9, 2017

Present: Jo Franklin, Dave Neuger, Kathy Shea, Sue Sharrow, Jane Rinehart Guests: Pr Pam, Sue Brockman from the Children's Board, Dan Franklin from the Youth Board, nonprofit presenters, as noted below.

We spent the evening reviewing grant proposals for the benevolence portion of the 150th Anniversary fund appeal. Five nonprofit organizations had been previously selected by the B&SC board from the 14 grants submitted. The 5 presentations were:

- 6:30 Jim Blaha and Carol Gengenbach, CAC
- 6:50 Linda Hibbard, Epic Enterprise Inc
- 7:10 Marnie Thompson and staff, TORCH
- 7:30 Dayna Norvold, Rice County Habitat
- 7:50 Sandi Gerdes and staff, Laura Baker Services

After the presentations we discussed the pros and cons of the proposals, and then we each gave our rankings of the five. We decided to eliminate the Epic proposal, as it was not clear how the plan would be implemented, and the sustainability was not clear.

The remaining 4 proposals were ranked as follows. How many of the proposals are funded depends on how much money is raised. If there is \$100,000 designated for benevolence, we recommend spending these amounts:

- 1. TORCH Tackling Obstacles, Raising College Hopes \$38,900. Goal: develop an Alumni Center that would support all recent NHS graduates to reach their full potential through outreach and advising, college access resources, and career service. Total cost of the project is \$78,800, with remaining funds obtained from local, state and national grants and foundations.
- 2. Laura Baker Services Association: \$17,000 for Community Building through Music, Art and Technology. LBSA and St. John's Lutheran would use music, art and a special art iPad technology to develop and sustain relationships. The Wed. night meals would be used to promote these relationships with guidance from LBSA staff.
- 3. Community Action Center (CAC). \$20,000 as a leadership gift toward building 2 emergency shelter units on land that would be leased next to the Manger Inn (now called the Human Capital Development Foundation, or HDCF Community). Total cost of the project is projected to be \$150,000. CAC would secure the remaining funds from other county, state and national sources.
- 4. Rice County Habitat for Humanity. \$20,000 leadership gift from St. John's for the first Faith Builder home in Northfield in 2019. Total cost of a home is \$120 140,000.

Other local churches would be sought by Habitat to participate. Habitat provides stable, long term housing, which "impacts generations to come. . . this is a proven way to end generational poverty."

Total cost for the first 2 programs: \$55,900

Total cost for all 4 programs: \$95,900.
